 - C. The Entry Level Firefighter/Paramedic Primary Eligibility List will be extended in the very near future, with the next 25 candidates to be granted an oral interview on June 17, 2019.
 - D. The July Board of Fire and Police Commissioners meeting is canceled due to the holiday.
